These particular Accommodation places are across multiple areas. 6 of these rooms are on the western side of House 1 and 30 of are located in House 3. These rooms are all private and self-contained, and are close in proximity to dining and nursing facilities. All aspects of the facility are well maintained by maintenance officers. Spacious well-lit room with ample built-in storage, including wardrobe and drawers. Large ensuite includes storage area for toiletries etc. Individual climate-controlled Air Conditioner. TV outlet including 24-hour Satellite Greek TV entertainment. Kitchenette cupboard and sink facilities. Large window looking out onto garden or courtyard. The consumers of the six House 1 rooms may dine in the more appropriate of either of the House 1 dining rooms.
